## The Results Of Our 16th Annual Best S.A. Lawyers Survey

AS NOMINATED BY THEIR PEERS

**A**s we have done for each of the last fifteen years, we asked licensed, practicing lawyers of Bexar County to tell us who they believe are the city's best lawyers and attorneys at law in 80 distinct areas of practice. They can't vote for themselves and they can't just give us names of their law partners without giving us the name of others outside their practice.

We have added a further distinction. We have calculated how long each referred lawyer has been in practice and displayed each in their appropriate group: 15+ years in practice (the "most experienced") then 5 to 15 years in practice (not the most experience but certainly "well established") and then those who have been in practice less than five years. Of course all of the survey data in the world is meaningless

without results. Our survey cannot predict results for those who practice law and those who engage them to achieve results.

We do know this: Unlike many other societies on this earth, we live in a society that is largely structured by law. Law protects private property for the benefit of the living, the dead or those yet to be born. Law protects our person and property from harm by willful force and other acts of nefarious men. Law provides for our right to "due process" if society or its actors try to take our freedom or our property. The law defines the pathways by which we create, build, protect and convey all value and lawyers are our guides down those pathways. Sometimes the law and lawyers can achieve justice.

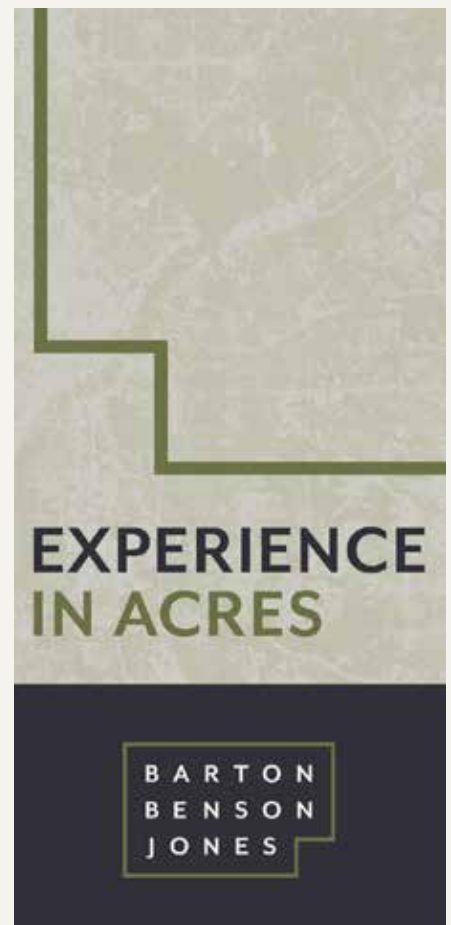
